ORDER:

In the G.O.third read above, the Government have revised and laid down the following-procedure for allotment of apartments under Tamil Nadu Government Servants Rental Housing Scheme:-

1. For out of turn allotment - Two vacancies.
2. For the local employees - Three vacancies.
3. For better accommodation - Three vacancies.
4. For Transferee & Newly married - Two vacancies.

2. Considering the receipt of large number of petitions from Government Servants for allotment of rental apartments on out of turn basis, The Government have decided to revise the above procedure. The Government accordingly direct that the allotment of apartments under Tamil Nadu Government Servants Rental Housing Scheme be made as follows:-

1. For Out of turn allotment - Four vacancies.
2. For the local employees - Three vacancies.
3. For better accommodation - One vacancy.
4. For Transferee and Newly married; Two Vacancies.

Out of turn allotments will be made by the Hon'ble Minister in-charge of Housing.

3. This order will take effect from the date of issue of this order.
